



Waiver and Release of Liability Form

Dear Bionerds client,

Hands-on science experiments and activities are a great way to introduce to our children the wonderful living things surround us. This hands-on learning will help them understand better and satisfy their curiosity. As wonderful and exciting these activities are, they also involve risks. Please read this form carefully and be aware that in registering your child for participation in Bionerds program(s), you will be waiving and releasing all claims for injuries your child might sustain arising out of the said program(s).

By registering your child for Bionerds' program, you are aware of the inherent, as well as unknown, unforeseen, unanticipated, and unsuspected risk of injury, bites, allergic reactions, trauma, death, and property damage associated with hands-on science activities. In the laboratory or classroom, your child will be introduced to and worked with to include but not limited to chemicals, laboratory tools, and equipment, as well as living and preserved organisms. As part of this agreement, you acknowledge that all such risks exist and that you have allowed your child to attend the workshop knowing of these risks and all of their possible consequences. You acknowledge further that injury, trauma, death, or damage may occur even when Bionerds and others have exercised due and reasonable care in relation to your child.

As a parent or guardian of your child, by signing this document, you agree to waive any claim you may have against Bionerds, LLC, its officers, its agents, and all of the employees on the injury, death, and property damage resulting from the risks described above. You agree further to waive and not to assert any claim for injury, death, or property or any other damage against Bionerds, LLC, its officers, its agents, and all of the employees.

It is very important for your child to follow Laboratory Rules and Safety Guidelines provided by Bionerds, LLC. It is important for you to review these guidelines with your child to ensure understanding and cooperation when working in the laboratory. It is important that you contact and inform Bionerds, LLC personnel directly and not through your child in the event in which you do not want your child to participate or any other concern. By signing this document, you understand and agree that in the event your child causes any harm or damage to another child, including being responsible for indemnifying Bionerds, LLC, and its personnel should they be forced to defend themselves in connection with any resulting lawsuit or claim.

You understand and agree that in the event any dispute arises between you, either personally or on behalf of your child, and Bionerds, LLC, or their personnel, that dispute will be decided according to the laws of the State of California.

I hereby consent the photographing, recording, reproduction of any other manner (including use of video and audiotapes) of the likeness, voice and/or activities of the participant and further authorize Bionerds, LLC to make unlimited use of company promotions, including but not limited to broadcasting of reproductions over the radio, television, and on the Internet (including social networking). I understand that I will not receive any monetary compensation now or in the future of participating. I do hereby release and hold harmless Bionerds, LLC, its officers, and employees from any claims.
